A returning resident must submit a copy of his/her South African passport or identity document (page with photo and details), letter from employer confirming permanent employment abroad reflecting the period of employment, a copy of the official foreign vehicle registration certificate and the duly completed application form.

Bona fide immigrants must submit a copy of the South African permanent residence certificate, copy of foreign passport (page with photo and details), copy of official foreign motor vehicle registration certificate and the duly completed application form.

An application for an import permit can be considered without a copy of the South African Bureau of Standards Letter of Authority (LoA) and can be approved in principle, but the permit cannot be issued without a copy of the LoA.
